**Campaign Strategy:** On October 13th, Texas State University summarily fired Tom Alter for exercising his free speech rights at a Socialism conference. Tom was fired because he is a Socialist. His termination is an expression of MAGA McCarthyism's attacks on the Left, on DEI, on immigrants, migrants, Palestinians, trans and queer people, and anyone who dissents from the current regime.

### Statement of Dr. Thomas Alter

Issued 10/13/25

I stand in opposition to Texas State University's attack on democratic rights that are protected by the Texas and United States Constitutions as well as the academic freedom that was once the hallmark of Texas higher education.

To be clear, my termination is part of a broader political attack being carried out by the authoritarian far-right to crush democracy and democratic institutions in the United States in general and Texas in particular. But the charges leveled against me by the Texas State University administration do not stand up to the facts; I have truth on my side and I look forward to my day in court.

My termination, in clear violation of my First Amendment rights to freedom of speech, association, and of assembly brings shame, embarrassment and a heavy blow to the academic reputation of Texas State University. This hurts not only faculty, staff, current students and alumni but the San Marcos community as well.

This fight did not start with me and it does not end with me. I want to thank my unions, the Texas State Employees Union, American Association of University Professors, and Texas-AFT; the broad coalition of democratic rights supporters in the Committee to Defend Tom Alter; the Texas State chapter of the Young Democratic Socialists of America; Socialist Horizon; and all those who value basic democracy.

### Texas State Terminates Professor for Protected Speech; Major Unions and Civil Liberties Groups Vow to Fight Back

SAN MARCOS, Texas (October 14, 2025) — Texas State University President Kelly Damphousse has terminated Professor Tom Alter for engaging in protected political speech as a private citizen, the Committee to Defend Tom Alter announced today. The decision represents a direct assault on the First Amendment and academic freedom.

In a public statement released after his firing Alter said: "My termination, in clear violation of my First Amendment rights to freedom of speech, association, and of assembly, brings shame, embarrassment and heavy blow to the academic reputation of Texas State University." Alter also commented: "To be clear, my termination is part of a broader political attack being carried out by the authoritarian far-right to crush democracy and democratic institutions in the United States in general, and in Texas in particular. But the charges leveled against me by the Texas State administration do not stand up to the facts. I have truth on my side and I look forward to my day in court."

Because of his termination Alter's lawsuit against Texas State seeking his reinstatement will now go forward.

The Texas State Employees Union, American Association of University Professors, Texas AFT, and Texas AFL-CIO have condemned the termination and pledged full support for Dr. Alter's legal challenge. Civil liberties organizations nationwide are rallying to overturn this precedent-setting case.

"This is violation not only of academic freedom, but the basic constitutional protection of free speech under the First Amendment," said Bill V, Mullen, coordinator of the Committee to Defend Tom Alter. "If this can happen to Tom Alter, it can happen to anyone. That is why there is a growing campaign to defend Dr. Alter, because if he loses his right to free speech, everyone's right is at risk."

### **An Unconstitutional Termination**

Dr. Tom Alter, a tenured history professor, was terminated for speaking at a political conference on his own time as a private citizen. The proceedings began after far-right provocateur Karlyn Borysenko posted secretly recorded and selectively edited videos from the September 7 Revolutionary Socialism Conference demanding his firing.

The First Amendment protects political speech made as a private citizen. Texas State's termination constitutes retaliation against speech unrelated to Dr. Alter's employment and sets a dangerous precedent threatening academic freedom nationwide.

### **Labor and Civil Liberties Coalition Mobilizes**

Major labor organizations including the Texas State Employees Union, American Association of University Professors (AAUP), Texas AFT, and Texas AFL-CIO are backing Dr. Alter's fight.

Civil liberties organizations, faculty groups, and student organizations across the country have mobilized in support.

#### **Timeline of Events**

- September 7: Alter speaks at Revolutionary Socialism Conference as private citizen
- September 8: Borysenko posts manipulated videos demanding firing
- September 10: Texas State terminates Alter without due process
- September 26: Court orders proper procedures
- October 13: Damphousse terminates Alter

"This struggle did not begin with me, it will not end with me," Dr. Alter said. "The struggle for free speech will continue regardless of the outcome. If it is positive it will be a victory that will strengthen the struggle to defend hundreds others being attacked, fired and persecuted for their ideas. If it is negative, we will be on the front line of that struggle nonetheless."
